- *Dogwize [A Doggie Day Care and Puppy Crèche Service] has the right to refuse or cancel any pet's enrolment.*
- *Legislation requires specific approval from each owner for their pet to socialise and mix with other animals. Otherwise the Act states that they must be kept in pens. Dogwize WILL NOT keep dogs in pens. Your signature below approves this socialisation.*
- *Dogs socialise and adjust without their owners. Please contact Lorraine if you want to visit your dog during working hours.*
